### ANNUAL/LONG SERVICE/SABBATICAL LEAVE:

# PER MONTH

Every priest is encouraged and permitted to take one month of Annual Leave per year (once every 12 months). This month, taken continuously or intermittently, should include no more than 5 weekend absences from a parish and a maximum of 31 days.

A priest is permitted to take one month of **Sabbatical Leave** for every 10 years of service since Diaconate Ordination. A priest is permitted to take two months of Long Service Leave for every 10 years of service since Diaconate Ordination. If more leave is needed for other reasons, permission can be obtained through the Vicar General. Long Service/Sabbatical Leave should be arranged with the Vicar General 9 months in advance.

All leave is a benefit, is not accrued and is not taken as a reimbursement for expenses.

## Nuptial Stole Offering

Clergy may keep a portion of the Nuptial Offering up to \$125. The remainder of any wedding donation is Pastoral Revenue Income.

### **NOTES ON SUPPLIES:**

- 1. Tax File Number must always be recorded for any payment and Superannuation number will be needed if payment exceeds \$450. (TFN and Super are not applicable to religious.)
- 2. Some retired priests elect to supply without remuneration their payment/travel allowance is to be transferred directly to the CDF Priests' Retirement Foundation Account Number 641s52.7 (Please note the supply priest's name as the reference.)
- 3. Where an active priest already receives a monthly stipend from a parish or from the Archdiocese, a priest should be willing to assist with Masses/Reconciliations (without receiving a supply stipend). If circumstances demand that an offering feels necessary because a priest has already celebrated 3 Sunday Masses, then the maximum payment to be received per Sunday Mass is \$50, with no superannuation or travel allowance applicable. TFN will still need to be sighted prior to paying this discretionary payment to active priests.
- 4. Super Guarantee of 9.5% is to be paid from the Church Account when the supply payment to an individual priest in a calendar month exceeds \$450 in the same parish – applicable only when the supply payment is paid directly to the priest.
- 5. If a priest from outside the parish is visiting and stays in a presbytery as a guest and wishes to celebrate a parish Mass, he should not be paid a supply stipend for Mass. Usual protocols for visiting priests apply.
